DISASTER RELIEF ASSISTANCE FOR IMMIGRANTS (DRAI)



- State-funded disaster relief assistance to undocumented adults who are ineligible for other forms of assistance because of their immigration status.
- Reached 150,000 undocumented adults.
- Eligible adult received \$500 in direct assistance, with a maximum of \$1000 in assistance per household.
- Eligibility
 - (1) undocumented adult (person over the age of 18);
 - (2) not eligible for federal COVID-19 related assistance;
 - (3) have experienced a hardship as a result of COVID-19.






