 - 4.1. Rail Transit Projects Update

Preston provided an overview of the rail line's history, and the status of Coastal Rail Trail projects under development. A 2019 study proposed a multi-modal (rail, bus, bicycle, etc.) infrastructure plan designed to promote a sustainable transportation system. A 25-year business plan to modernize the rail line was not approved by the Santa Cruz County Regional Transportation Commission. Measure D. will fund rail line preservation but not refurbishment and alternate funding has not been identified. A projected 3K community members would use the passenger rail. The Greenway Trail referendum will not impact existing RTC funding for railways.

4.2. 2021 Strategic Action Plan Ad Hoc Subcommittee Appointments

Motion to cancel the 2021 Community Art Wall Project Motion/Second: Hernandez/Alfaro Ayes: Granados, Gomez, Alfaro, Hernandez, Garcia Abstain: Gonzalez Motion passed.

4.3. County Redistricting Efforts

Commission reviewed an overview of the County's redistricting efforts. Garcia expressed concerns that there does not appear to be Latino representation on the ARC 21 Commission. Commission will continue to monitor redistricting for Cabrillo College and the Santa Cruz County Office of Education in addition to County Supervisorial districts. Staff will share additional information as it becomes available.

5.1. Pajaro Valley COVID-19 Outreach Task Force Representation Report pended to next meeting, as Mendez was unavailable to report. Item will be removed from the agenda if Mendez has not attended these meetings.

Gomez reported that since the CZU wildfires, insurance companies are canceling policies despite the Insurance Commissioner's moratorium on cancellations. District 5 residents are encouraged to contact their congressional representatives.

6.6. Santa Cruz City Report (Hernandez):

Hernandez reported on a recent shooting of a young indigenous man. Hernandez is a member of the Rise Together group (leaders of color working with the Community Foundation to advance racial equity locally. Commissioners are encouraged to learn more about the group.

6.7. Santa Cruz City Report (Alfaro):

Alfaro reported that the City building's Black Lives Matter mural was vandalized. The last Santa Cruz County mission bell will be removed to acknowledge the systemic oppression of indigenous peoples. City of Santa Cruz redistricting meetings are ongoing. The housing element (analysis of community housing needs for all income levels) update will be released soon. Santa Cruz County is eligible for \$12M per year for the next ten years in disaster low-income housing tax credits (LIHTCs) to build affordable housing which could result in up to 5 new developments being approved. *Yes, In My Back Yard* (YIMBY) will host a "Missing Middle Affordable Housing Tour. Housing Santa Cruz County is recruiting for a new executive Director, and now has a full Board of Directors.

6.8. Watsonville City Report (Garcia):

Garcia attended a Watsonville Senior Center luncheon and presented Mardi Gras beads to seniors in attendance. Commissioners are encouraged to support senior activities. The Watsonville City Council Policing and Social Equity Ad Hoc Committee received findings on recent community meetings and will determine and present final recommendations to the City Council.

Staff reported that the EEO/CC Plan and the Diversity, Equity and Inclusion Survey remain under review. 2021 Commission meeting locations have yet to be determined, pending the outcome of legislation.

Santa Cruz County Latino Affairs Commission 2020 - 2021 Biennial Report

1. THE ROLE OF THE COMMISSION

The Latino Affairs Commission is an advisory body to the Board of Supervisors on issues affecting the Latino community in Santa Cruz County. The Commission was established to:

- a. Advise the Board of Supervisors on any significant problems currently encountered by the County's Latino residents;
- b. Review the needs of Latino citizens in the County, and recommend comprehensive goals and objectives for effectively meeting those needs;
- c. Monitor the various services made available to Latino citizens by public and private agencies in the County and make recommendations to the Board of Supervisors on how County government can help ensure effective and efficient delivery of those services;
- d. Develop a procedure to identify and set priorities regarding the areas of greatest need for County support and/or attention, and prepare biennial recommendations to the Board of Supervisors regarding specific courses of action in response to identified needs and priorities;
- e. Advise the Board of Supervisors how best to cooperate with local, State, Federal and private agencies serving Latino citizens, and assist in the preparation, implementation, and review of any regional plan or program designed to serve Latino citizens;
- f. Advise the Board of Supervisors how best to cooperate with local, State, Federal and private agencies in order to maximize the availability of funds to meet the specific economic needs of the Latino population, with the objective of leveraging such funds to the greatest degree possible.

2. MEETINGS DATES, TIME, AND LOCATION

Latino Affairs Commission meetings are scheduled for the first Wednesday of every other month (February, April, June, August, October, and December), from 6:00 until 7:30 PM at the United Way of Santa Cruz County office (4450 Capitola Rd, Suite 106, Capitola, CA 95010). During the COVID-19 pandemic, the Commission met remotely instead.

- In 2020, one regularly scheduled meeting was canceled for health and safety reasons immediately following Governor Newsom's initial Stay-at-Home order.
- In 2021, one of the six regularly scheduled meetings was canceled for lack of quorum.

3. COMMISSION STRUCTURE

The Latino Affairs Commission is composed of seven voting members; one Commissioner appointed by each of the five District Supervisors to represent their districts, and two at-large Commissioners each, appointed by the cities of Santa Cruz and Watsonville to represent their

cities. Commission leadership (Chair and Vice Chair) elections are held each year during the April regular meeting.

The subcommittee may hear reports from community partners and is empowered to make reports and propose recommendations to the Commission within their subject matter jurisdiction as needed. As of December 31, 2021, Commissioner Mendez was the only subcommittee member.

Community Outreach Subcommittee

The Community Outreach Subcommittee is a publicly-noticed, standing subcommittee, convened as needed and authorized to promote the interests of the Santa Cruz County Latinx Community through outreach and provision of resources by hosting, supporting or attending events, providing resources and referrals, and hearing reports from community partners as needed. The subcommittee is empowered to make reports and propose recommendations to the Commission within their subject matter jurisdiction as needed. As of December 31, 2021, subcommittee members included Commissioners Alfaro, Garcia and Granados.

Diversity, Equity & Inclusion Subcommittee

The Diversity, Equity & Inclusion Subcommittee is a publicly-noticed, standing subcommittee, convened as needed and authorized to monitor and promote diversity, equity and inclusion in Santa Cruz County by reviewing the County's Equal Employment Opportunity and Cultural Competence Plan and policies, and hearing reports from local services, programs and agencies regarding their diversity, equity and inclusion efforts. The subcommittee is empowered to make reports and propose recommendations to the Commission within their subject matter jurisdiction as needed. As of December 31, 2021, subcommittee members included Commissioners Alfaro, Hernandez, Gomez and Gonzales.

Affordable Housing Subcommittee

The Affordable Housing Subcommittee is a publicly-noticed, standing subcommittee, convened as needed and authorized to monitor housing issues, advocate for legislation that creates or maintains affordable housing stock and promote affordable housing for the Santa Cruz County Latinx community. The subcommittee is empowered to make reports and propose recommendations to the Commission within their subject matter jurisdiction as needed. As of December 31, 2021, subcommittee members included Commissioners Alfaro and Gonzalez.

9. COMMISSION ACCOMPLISHMENTS AND SPECIAL PROJECTS

During the reporting period, the Commission addressed the following issues:

- Advocacy letter to the Board of Supervisors expressing concern about the disproportionate impact the Coronavirus pandemic is having on the Latinx community in Santa Cruz County
- Advocacy letter to the Board of Supervisors in support of the efforts of local collaborative, PPE for Central Coast (PPE4CC) to address the disproportionate impact the pandemic was having on the Latinx community in Santa Cruz County.
- Advocacy letter to the Board of Supervisors requesting representation on the ad hoc CARES Justice advisory body and the subsequent Commission on Anti-Racism, Economic and Social Justice
- Memo providing detailed feedback on the County's Equal Employment Opportunity and Cultural Competence Plan
- Advocacy letter to Governor Newsom expressing appreciation to for the appointment of Senator Alex Padilla to the United States Senate, filling the seat vacated by Vice President Kamala Harris and encouraging continued prioritization of the ongoing dialogue with communities of color.

10. FUTURE GOALS AND RECOMMENDATIONS

In 2022-2023, the Latino Affairs Commission will endeavor to:

- Promote diversity, equity and inclusion for the Latinx community in Santa Cruz County
- Provide representation on the County's CARES Justice Advisory body and subsequent CARES Justice Commission and monitor CARES Justice activities
- Monitor ongoing efforts to support economic recovery from the pandemic in the Latinx community
- Monitor ongoing efforts to promote COVID-19 vaccine distribution in the Latinx community
- Monitor and participate in activities that promote affordable housing opportunities for the Latinx community
- Promote awareness of the Commission by attending and supporting local events aligned with the Commission's scope and purpose

In 2022-2023, the Latino Affairs Commission recommends that the Board of Supervisors take the following actions:

- Continue to provide policy leadership and funding support to County efforts designed to ensure diversity, equity and inclusion in County programs and services
- Include an at-large seat on the CARES Justice Advisory body and subsequent CARES Justice Commission for representation from the Latino Affairs Commission
- Provide policy leadership and funding support to programs tasked with supporting economic recovery from the COVID-19 pandemic in the Latinx community
- Provide policy leadership and funding support to programs promoting COVID-19 vaccine distribution in the Latinx community
- Continue to monitor local affordable housing efforts and provide policy leadership and funding support to agencies and programs implementing solutions to the housing crisis
- Provide policy leadership and funding support to programs tasked with expanding broadband access to underserved areas of the County, particularly those where a technology gap may be disproportionately impacting the Latinx community

SANTA CRUZ COUNTY LATINO AFFAIRS COMMISSION'S FINDINGS PURSUANT TO ASSEMBLY BILL 361 AUTHORIZING TELECONFERENCE MEETINGS AS A RESULT OF THE CONTINUING COVID-19 PANDEMIC STATE OF EMERGENCY AND HEALTH OFFICER RECOMMENDATION FOR SOCIAL DISTANCING

WHEREAS, The Santa Cruz County Latino Affairs Commission is a legislative body under the Brown Act as defined under Cal. Gov. Code section 54952(b) and Santa Cruz County Code Section 2.38.110; and

WHEREAS, on September 16, 2021, Governor Newsom signed Assembly Bill 361 ("AB 361"), urgency legislation effective immediately, that amended Government Code section 54953 to permit legislative bodies subject to the Brown Act to continue to meet under modified teleconferencing rules provided that they comply with specific requirements set forth in the statute; and,

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(1)(A), a legislative body may meet under the modified teleconferencing rules during a proclaimed state of emergency, and where local officials have imposed or recommended measures to promote social distancing; and

WHEREAS, on March 4, 2020, Governor Newsom issued a Proclamation of State of Emergency in response to the COVID-19 pandemic, and which remains in effect; and

WHEREAS, on September 30, 2021, Santa Cruz County Public Health Officer Dr. Gail Newel strongly recommended that legislative bodies in Santa Cruz County continue to engage in physical/social distancing by meeting via teleconference as allowed by AB 361 and confirmed that she will regularly review and reconsider this recommendation and notify the public when it is no longer recommended; and

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(3), within 30 days of the date the legislative body first holding a teleconferenced meeting under the modified rules, and every 30 days thereafter, a legislative body can continue to hold such teleconference meetings provided it has reconsidered the circumstances of the state of emergency and determined either that the state of emergency continues to directly impact the ability of the members to meet safely in person or that local officials continue to recommend measures to promote social distancing; and

WHEREAS, on December 1, 2021, The Santa Cruz County Latino Affairs Commission held its initial teleconference meeting under AB 361; and

WHEREAS, this Santa Cruz County Latino Affairs Commission has reconsidered the circumstances of the current state of emergency and finds that the COVID-19 pandemic continues to directly impact the ability of members of the public to participate safely in person

and further finds that the Santa Cruz County Public Health Officer continues to recommend measures to promote social distancing; and

WHEREAS, in the interest of public health and safety, and due to the emergency caused by the spread of COVID-19, the Santa Cruz County Latino Affairs Commission deems it necessary to utilize the modified teleconferencing rules set forth in AB 361;

NOW, THEREFORE, the Santa Cruz County Latino Affairs Commission makes the following findings by a majority vote:

Section 1. The foregoing recitals are true and correct, and adopted as findings of the Santa Cruz County Latino Affairs Commission.

Section 2. Effective immediately, and for the next 30 days, the Santa Cruz County Latino Affairs Commission will meet via teleconference as authorized under AB 361 and Government Code section 54953(e)(3).

Section 3. No later than thirty (30) days from making today's findings, or at the next scheduled meeting, the Commission will reconsider the circumstances of the COVID-19 state of emergency and, if necessary, adopt subsequent findings to continue holding teleconference meetings in accordance with Government Code section 54953(e)(3).
