4. New Business/Action Items

4.1. CARES Justice Advisory Group Update

Stafford updated the Commission on the *CARES Justice Advisory Group* including their decision to continue as an advisory body rather than forming a Commission. Instead, they will focus on project-based work within the County Public Health Division, supporting the County Health Equity Officer's efforts to address health care inequities in Santa Cruz County. Community guidelines for projects are being established which may increase opportunities for Commission engagement.

4.2. Consider Approving the 2020-2021 Biennial Report

Commission reviewed the 2020-2021 Biennial Report, amended to include December meeting attendance, revise language and modify the goals and recommendations.

4.4. Consider Advocating for Implementation of Grand Jury's broadband Recommendations Commission considered advocating for implementation of the Grand Jury's broadband recommendations beyond the recommendation included in the Biennial Report.

5. Ongoing Business:

5.1. Affordable Housing

Alfaro reported on recent unprecedented funding awards and tax credits (\$14M/year for 10 years) in the wake of the CZU Lightning Complex wildfires. Five affordable housing developments from Santa Cruz City to South County have been allocated the funds resulting in 300+ units of affordable housing starting construction in 2022.

Silva-Robles reported that Senderos is recruiting for an Executive Director. Community continues to recover from the impact of the COVID-19.

Gomez reported that redistricting redrew the District 5 boundaries to include Scotts Valley.

6.6. Santa Cruz City Report (Hernandez):

Hernandez attended two events downtown welcoming UCSC students back. Staff will look into the possibility of creating Commissioner name tags to identify Commissioners at community events.

6.7. Santa Cruz City Report (Alfaro):

Alfaro reported that Association of Monterey Bay Area Governments gave a presentation on the process by which State leaders set the Regional Housing Need Allocation (RHNA: home-building minimums required for each region to address the state's housing shortage) for an eight-year period. Santa Cruz City is establishing design standards to streamline the permitting process for affordable multi-housing developments. New Santa Cruz City Manager Matt Huffaker was formerly Watsonville's City Manager. Chair Alfaro announced her resignation (effective December 2, 2021), expressed her appreciation for the Commission's work and encouraged Commissioners to continue monitoring affordable housing.

6.8. Watsonville City Report (Garcia):

Garcia provided an update on ongoing redistricting efforts in five jurisdictions: Santa Cruz County Office of Education, Cabrillo College, Pajaro Valley Unified School District, County Supervisors and Watsonville City.

6.9. Watsonville City Report (Mendez):

Mendez reported no large school outbreaks and Watsonville City beginning to allow outdoor community events including the annual tree lighting.

7. Staff Report:

The EEO/CC Plan data is being updated with estimated publication in Q1 2022. No meeting room for 2022 has been established. Staff is working with County staff to establish fundraising parameters.

SANTA CRUZ COUNTY LATINO AFFAIRS COMMISSION'S FINDINGS PURSUANT TO ASSEMBLY BILL 361 AUTHORIZING TELECONFERENCE MEETINGS AS A RESULT OF THE CONTINUING COVID-19 PANDEMIC STATE OF EMERGENCY AND HEALTH OFFICER RECOMMENDATION FOR SOCIAL DISTANCING

WHEREAS, The Santa Cruz County Latino Affairs Commission is a legislative body under the Brown Act as defined under Cal. Gov. Code section 54952(b) and Santa Cruz County Code Section 2.38.110; and

WHEREAS, on September 16, 2021, Governor Newsom signed Assembly Bill 361 ("AB 361"), urgency legislation effective immediately, that amended Government Code section 54953 to permit legislative bodies subject to the Brown Act to continue to meet under modified teleconferencing rules provided that they comply with specific requirements set forth in the statute; and,

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(1)(A), a legislative body may meet under the modified teleconferencing rules during a proclaimed state of emergency, and where local officials have imposed or recommended measures to promote social distancing; and

WHEREAS, on March 4, 2020, Governor Newsom issued a Proclamation of State of Emergency in response to the COVID-19 pandemic, and which remains in effect; and

WHEREAS, on September 30, 2021, Santa Cruz County Public Health Officer Dr. Gail Newel strongly recommended that legislative bodies in Santa Cruz County continue to engage in physical/social distancing by meeting via teleconference as allowed by AB 361 and confirmed that she will regularly review and reconsider this recommendation and notify the public when it is no longer recommended; and

WHEREAS, pursuant to AB 361 and Cal. Gov. Code section 54953(e)(3), within 30 days of the date the legislative body first holding a teleconferenced meeting under the modified rules, and every 30 days thereafter, a legislative body can continue to hold such teleconference meetings provided it has reconsidered the circumstances of the state of emergency and determined either that the state of emergency continues to directly impact the ability of the members to meet safely in person or that local officials continue to recommend measures to promote social distancing; and

WHEREAS, on February 2, 2022, The Santa Cruz County Latino Affairs Commission held its initial videoconference meeting under AB 361; and

WHEREAS, this Santa Cruz County Latino Affairs Commission has reconsidered the circumstances of the current state of emergency and finds that the COVID-19 pandemic continues to directly impact the ability of members of the public to participate safely in person and further finds that the Santa Cruz County Public Health Officer continues to recommend measures to promote social distancing; and

WHEREAS, in the interest of public health and safety, and due to the emergency caused by the spread of COVID-19, the Santa Cruz County Latino Affairs Commission deems it necessary to utilize the modified teleconferencing rules set forth in AB 361;

NOW, THEREFORE, the Santa Cruz County Latino Affairs Commission makes the following findings by a majority vote:

Section 1. The foregoing recitals are true and correct, and adopted as findings of the Santa Cruz County Latino Affairs Commission.

Section 2. Effective immediately, and for the next 30 days, the Santa Cruz County Latino Affairs Commission will meet via teleconference as authorized under AB 361 and Government Code section 54953(e)(3).

Section 3. No later than thirty (30) days from making today's findings, or at the next scheduled meeting, the Commission will reconsider the circumstances of the COVID-19 state of emergency and, if necessary, adopt subsequent findings to continue holding teleconference meetings in accordance with Government Code section 54953(e)(3).
